About Mediterranean Coast Day

Mediterranean Coast Day, which is celebrated on 25 September, is an initiative to promote the Integrated Coastal Zone Management (ICZM) as the optimal policy framework for achieving sustainable development of coastal areas, and the PAP/RAC, the Coastal Management Centre of UNEP/MAP, is the promoter of this action in the Mediterranean Region.

This initiative aims to increase environmental awareness among policy makers, academics, media, civil society and local populations, but also to promote and implement activities that, at the same time, consider fragile, ecological, social and cultural contexts and lead to sustainable coastal development.

Greece is the host of the 2021 edition of Mediterranean Coast Day.

Background

The Mediterranean is the most densely populated closed sea in the world. The total population of the Mediterranean countries grew from 276 million in 1970 to 512 million in 2018. It is predicted to grow by an additional 182 million inhabitants by 2050. In 2019, the percentage of built-up areas has

reached an astounding rate. The coastal zone is becoming increasingly populated and built up and concentrates most of the major cities, many transport routes (roads, ports, airports), as well as industrial and energy infrastructure. This concentration is intensifying year after year and generates more pollution and disturbance leading to environmental degradation and increased risks for coastal populations and infrastructure. Besides these pressures in coastal areas, natural hazards such as storms and flooding add to the overall challenge. As their frequency, occurrence and intensity increase, they pose a real threat and weaken the resilience of ecosystems, human populations and coastal infrastructure. (UNEP/MAP and Plan Bleu, 2020)¹.

The webinar

As part of the celebration of Mediterranean Coast Day, the proposed reflection will take place on the 27 September 2021, and will address two crucial and connected issues: coastal urbanisation and tourism. Both issues will be approached through in the prism of the post-Covid era and the changing climate. Pathways to promote sustainable tourism in the Mediterranean and to address related challenges will be presented.

The reflection will take the shape of a moderated webinar.

<p>Daria Povh Škugor is a senior programme officer at PAP/RAC, dealing with ICZM and adaptation to climate change for more than 15 years. In her work she is committed to creating enabling environment for action towards sustainable development.</p> <p>She was among others responsible for preparation of the Coastal Plan for the Šibenik – Knin region, project awarded in 2019 as the best Mediterranean adaptation initiative during the “Mediterranean Climate Change Adaptation Award” organized by the French Environment Agency (ADEME) and their 3 partners. The coastal plan was awarded in the competition of 28 projects for the category “Methods for designing and implementing public policies”, but also for the overall award. Recently PAP/RAC has been involved in preparation of 10 more Coastal plans around Mediterranean, ranging from the role of participating in the Advisory board to the implementing agency.</p>	
<p>Matea Dorčić, a law graduate, has recently become Head of the Administrative Department for Tourism and Maritime Affairs of the Split-Dalmatia County in Croatia. She has been working for the Split-Dalmatia County since 2014, after gaining extensive experience in the private sector. In 2019 she co-founded the “Maritime Domain is Good – Pomorsko je dobro” Project, created with the aim of achieving more transparent, responsible and efficient maritime domain management and valorisation, providing support for local self-government units, bringing order to how that valuable resource is used, and protecting and preserving it.</p> <p>In 2020, the project received the most prestigious professional award in Croatia – the Grand Prix 2020 – namely for the category of public relations in regional and local self-government units, awarded every year by the</p>

<p>Gloria Lazarao is programme officer at Plan Bleu, coordinating a portfolio of projects with focus on sustainable tourism and biodiversity protection. With a background on environmental sciences, Gloria has worked for over 10 years on sustainable development initiatives related to ecosystem restoration, flood risk prevention and water management.</p> <p>She worked in a consultancy for 4 years in the implementation of the Water framework Directive and in the River Restoration National Strategy, in Spain. Before joining Plan Bleu, Gloria worked in climate change adaptation, mainly focused on floods: for the Algerian flood risk prevention National Strategy and for the European centre for flood risk prevention – CEPRI- (Orléans, France). Gloria has contributed to the H2020 AMBER project which has completed the first European Atlas of rivers barriers and recently published an article on river fragmentation in Europe in Nature.</p>
